PART L GENERAL EXPECTATIONS

The Englewood on the Palisades Charter School agrees to implement the following statutory requirements:

3. The Englewood on the Palisades Charter School Computer Lab will be made available to parents as part of a workshop presentation to assist them in the development of their computer skills as they relate to the academic achievement and school performance of their child(ren).

4. The Englewood on the Palisades Charter School will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs:

Students that have been identified as having limited English proficiency will receive additional academic support to help them reach their full potential.

5. The Englewood on the Palisades Charter School will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title 1, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). Attend meetings to participate and discuss the key elements of the NJASK Test and the parents' responsibility/partnership in preparing the student for this state assessment.

The teaching staff has found that communicating the mandates of the school's test preparation program has provided our students an opportunity to achieve academic success.

B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

All parents are notified of the computer programs that are presently being used by the students i.e., Study Island, Writing Wizard, and other grade appropriate computer programs that are used to support and improve the academic achievement of our students.

All students throughout the school have access to the Computer Lab, and students are exposed to technology of our Smart Board. This is in addition to grade specific access to academic instruction on Smart Tables and Touch Screen Computers.

C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Professional Development workshops are provided to all staff members that highlight the importance of having a working/productive relationship with parents as valued members of the school community. These workshops help the staff identify specific areas whereby parents can become an integral member of the students' educational support system.

D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
